- Provide Child's Proof of Age
- Your child is enrolled in either Early Week or Late Week group 5 days per fortnight for the full 4 terms per year.
- Defaulting or failure to pay kindergarten fees will result in your child's placement being cancelled.

We are an approved Kindergarten program provider. Our service is licenced to provide an approved kindergarten program to up to 50 children (no more than 25 per group). To be eligible to receive funding we are required to provide an educational program that:

- is taught over 600 hours per year over 40 weeks;
- is taught by a qualified early childhood teacher;
- aligns with a program approved by the Queensland Curriculum and Assessment Authority;
- enrols children who must turn 4 by the 30th June 2024; and

is supported by assistant educators (currently two per group of 25 children which is above industry requirements).
