The Mudjimba Community Kindergarten is a non-for-profit organisation run by a Committee of volunteers.  
Mudjimba Community Kindergarten & Pre-School Association Inc.

The kindergarten employs two part-time Director/Teachers, four assistant educators as well as inclusion support educators as needed.

2024 kindergarten receives funding from the QLD Government for eligible children who attend the kindergarten.

We are an approved Kindergarten program provider. Our service is licenced to provide an approved kindergarten program to up to 50 children (no more than 25 per group). To be eligible to receive funding we are required to provide an educational program that:

- is taught over 600 hours per year over 40 weeks;
- is taught by a qualified early childhood teacher;
- aligns with a program approved by the Queensland Curriculum and Assessment Authority;
- enrolls children who must turn 4 by the 30<sup>th</sup> June 2024; and
- is supported by assistant educators (currently two per group of 25 children which is above industry requirements).
